

CONSULTANT COMMUNITY PARTNER PROGRAM

TERMS & CONDITIONS

Eleo provides a subscription based online Software as a Service (SaaS) solution for Non-Profit Organizations (NPO) to manage their donors (the Platform). Eleo informs, solicits, and distributes subscriptions to NPOs through various methods. Eleo recognizes that NPOs must manage and cultivate their donors in order to sustain the NPO's cause. The Eleo Platform provides an efficient and cost-effective tool for NPOs to meet this need.

Eleo also recognizes there is a vibrant consultant community that exists to guide and aid NPOs in sustaining their cause by cultivating donor relationships. Many smaller NPOs are not acquainted with donor management software, or how to organize their fundraising efforts. Therefore, in an effort to introduce Eleo's Platform to NPOs, Eleo wishes to engage nonprofit consultants to review and evaluate the Eleo Platform for their clients.

Consultant Community Partner Program:

Consultants who refer NPO clients to subscribe to the Eleo Platform, shall be compensated in the following ways:

- Initial referral payment of \$25.00, paid after 30 days
 - For Consultant to receive initial referral payment, NPO must remain a paying client for a minimum 30 days.
- Payment of \$25 every 6 months thereafter, that NPO remains subscribed to Eleo.
- If NPO is on an Eleo Opportunity Grant or Eleo Relief Grant, Consultant Partner Share is paused.
 - Consultant Partner Share of \$25 payments every 6 months will begin when the NPO's allocated grant period ends.

Consultant Community Partner Agreement:

- Consultant agrees to participate in a Live Personalized Demo to learn the Eleo Platform (if they have not had one prior).
- Consultant agrees to place Eleo's logo and a linkback to Eleo's website within the Consultant's website.
- Consultant agrees to follow Eleo's social media pages (Facebook, LinkedIn, etc.) if the Consultant is active on said networks.

- Eleo agrees to advertise Consultant Partner Profile within Eleo's Consultant Community page of Eleo's website. This includes the Consultant's logo and/or headshot, website, and brief description of services.
- Eleo agrees to follow Consultant's social media pages (Facebook, LinkedIn, etc.) if Eleo is active on said networks.

Terms:

- 1. This agreement will remain in effect until a cancellation is initiated by either party.
- 2. Either party is free to initiate the cancellation, at any time.
- 3. This agreement is nonexclusive to both parties.
- 4. The Consultant may refer and/or compare other software products to their clients.
- 5. Eleo may engage other Consultants within the Consultant Community Partner Program.
- 6. The relationship between Eleo and the Consultant established by these terms and conditions is that of an independent contractor and not an employee or agent of the other.
- 7. Each party shall be responsible for their own expenses, payroll, benefits, and taxes
- 8. Neither party shall misrepresent the relationship between Eleo and the consultant.
- 9. Consultant shall not assign or transfer this agreement without the written agreement of Eleo.
- 10. Consultant acknowledges that Eleo retain full and complete ownership rights in and to the intellectual property of Eleo, including without limitations, any Eleo trademarks or service mark.
- 11. Neither party shall make any warranties or guarantees, express or implied with respect to the Eleo Platform or any services.
- 12. Eleo shall not be held liable for any indirect, incidental, or consequential damages or any loss of revenue arising under this agreement.
- 13. This agreement is governed by the laws and jurisdiction of New Jersey.
